Figure 1.1: Aerial view of the building complex.

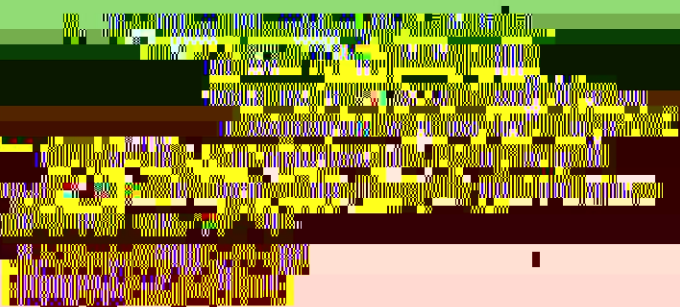


Figure 1.2: Aerial view of the building complex.

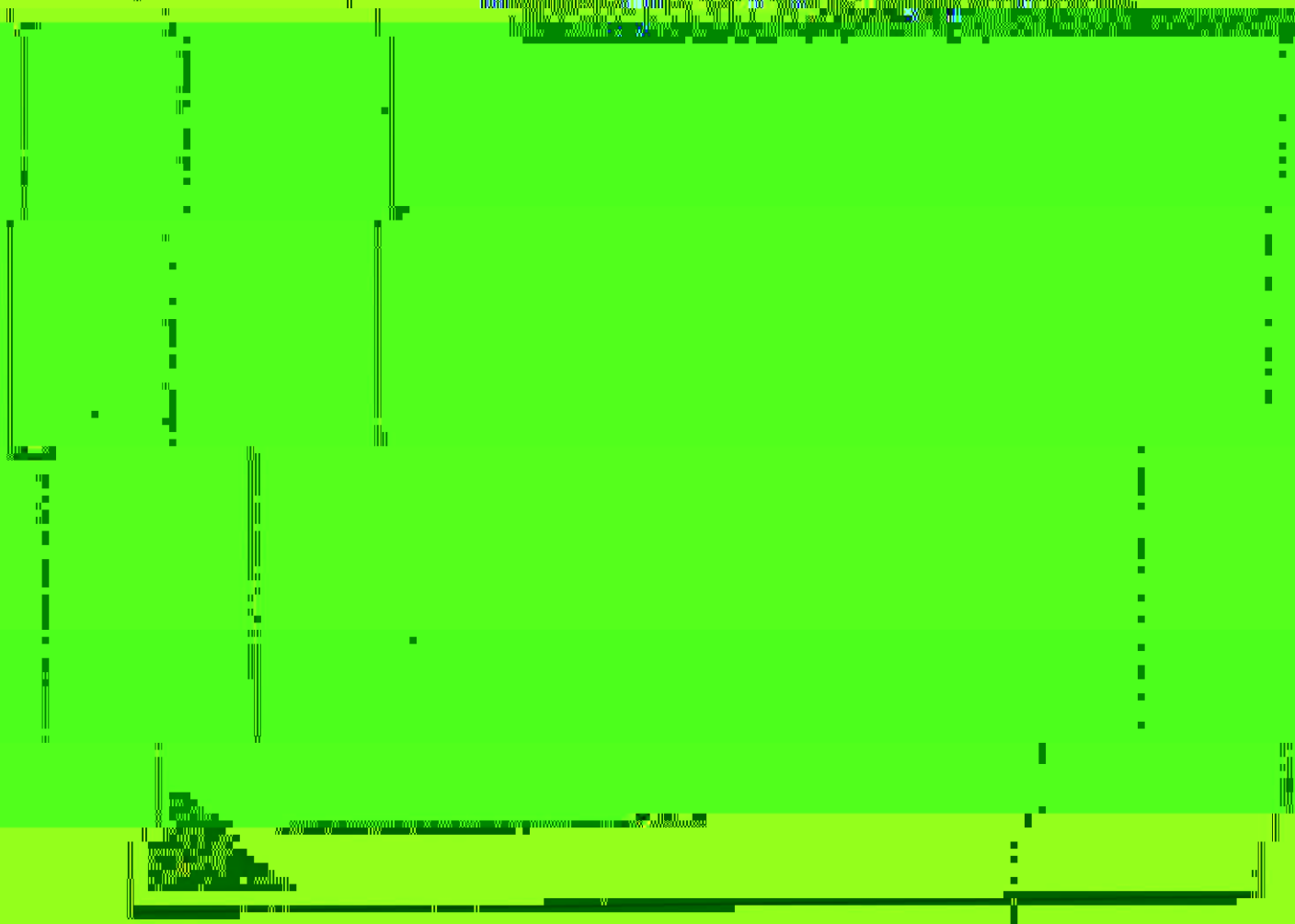


Figure 1.7: Aerial view of the building complex.
